

The James M. Kidd Award

The highest award given by the Northeastern Province shall be the

“The James M. Kidd Award”

To be eligible for this award, an Alumni candidate must have been a member of Kappa Alpha Psi for not less than five years and must have been in good financial standing during all of those five consecutive years. The candidate shall have rendered outstanding service to Kappa Alpha Psi, either nationally, to the Province or his local chapter, of such a nature that lasting benefits are accrued to the fraternity as a whole or to the Northeastern Province.

The James M. Kidd Distinguished Service Award shall be in the form of a suitably inscribed parchment Certificate and a suitably inscribed medallion. The James M. Kidd Distinguished Service Award shall be presented only as a programmed feature of the Province Closed Banquet at a Province Council session. The Certificate shall be signed by the Province Polemarch and the Chairman of the Achievement Committee and attested to by the Province Keeper of Record and Exchequer.

This petition must not exceed 75 pages. This size restriction is based on the fact that the NEP Achievement Awards Committee receives a large number of petitions and has only a 5-day window to read, analyze, compare and score them. Then the vendor needs three weeks to create and deliver the award sans edits or corrections. The NEP Achievement Awards Committee emphasizes ‘quality’ over quantity.

No more than two (2) James M. Kidd Distinguished Service Awards may be conferred in one year

PROCEDURE:

Candidates for The James M. Kidd Distinguished Service Award shall have their names submitted to the Achievement Committee on forms provided by the Province, these forms may be originated by any chapter, any group of five or more members of Kappa Alpha Psi who are in good financial standing or by the Achievement Committee.

A brief history of the candidates and the service for which he is being cited shall be included in the record. There shall be no limitation as to time of occurrence of the service, but it is to be understood that service referred to for this award is continuous service over a period of time consisting of three or more years as distinguished from incidental or specific instances of service.

The Achievement Committee shall receive all requests for the conferring of the ‘James M. Kidd’ Distinguished Service Award not later than one calendar month prior to the convening of the Province Council Meeting. The Achievement Committee shall thoroughly investigate the petitions received and shall in a Committee meeting, vote by a two-thirds (2/3) majority vote to award or deny the petition. The Achievement Committee may, if more than two members are deemed worthy of being conferred the award, vote to defer those in excess of two to later years.

Action taken by The Achievement Committee on all petitions shall be final, but shall be subject to reviewed by the Province Board of Directors to ascertain that all requirements of law and regulations have been complied.

The Achievement Committee in consultation with the Province Board of Directors shall determine the type and form of scroll to be used and shall cause the adopted form to be standardized, the citation and the contents or inscription of the scroll shall be prepared by the Achievement Committee.
